Grants-Jackson County grant rescinded. Put registration back to \$80, with 20% discount for coach kids and multiple children/family. No money to pay major league clinicians, but will accept volunteer help!

Business- Josh Lewis and Spy Academy will enter 1 each 9U and 13U team into our league. But they are not full teams so RYBSA will need to fill those rosters. Spy will help with sponsors and wear matching jerseys. They are also offering our registrants a \$25 monthly membership at the Dugout. We will broadcast the link.

-Changes in local structure: RBI baseball league will now be under major league, UYA, direction. Boys and Girls Club will have their own baseball and softball league. Unknown effect on our registration numbers.

-Little League affiliation. After discussion, we will pursue a direct charter. Benefits-lower insurance costs, potential registration scholarships, equipment donations, background checks, et al. Plan to use the Little League national recognition as drawing card for our league.

-Elementary school clinics are coming up as scheduled.

-Directors voted unanimously to remove Seana Berry as Director of Softball Operations due to her absences from meetings and our inability to get in contact with her. We advertised the position to parents of all last year participants. We interviewed Angela Calvert. She is enthusiastic about the revival of softball in Raytown! Beginning Mar. 1 she is willing and available to help in team formation, team coach assignments and player information, and practice schedules. Then she will be involved in player/parent issues, game schedules, and on-site supervision.
