



MJMH Policy #302: Tournaments
Updated: October, 2025

1. PURPOSE

This policy governs team participation in both home and outside tournaments for all divisions within the Moose Jaw Minor Hockey Association (MJMHA). It aims to provide clear guidelines for tournament limits, financial responsibilities, and the application process, ensuring fair and equitable opportunities for all teams while maintaining compliance with Hockey Saskatchewan regulations.

2. GENERAL

- 2.1. MJMHA recognizes the value of tournament play in player development and team bonding. However, all teams must adhere to the limits and procedures outlined in this policy to ensure the integrity of the regular season and playoffs.
- 2.2. The MJMHA Board of Directors reserves the right to approve or deny any team's participation in tournaments outside of the guidelines outlined in this policy.
- 2.3. All teams registered with MJMHA must receive approval from the MJMHA office to book and host a team-run tournament.

3. HOME TOURNAMENTS

- 3.1. The association-hosted tournaments will be held annually for U9 to U15 B/C Divisions.
- 3.2. Any teams hosting an association-run tournament will be required to remit all excess revenue beyond \$1,250.00 per team to the MJMHA.
- 3.3. The U7 Division will participate in a Jamboree, which is not considered a formal tournament.
- 3.4. The U13AA and U15AA Mavericks teams have specific tournament guidelines as determined by their external league, which may differ from this policy.

4. EXTERNAL TOURNAMENTS

- 4.1. Maximum Number of Approved Tournaments
Any tournaments being participated in must be sanctioned by Hockey Saskatchewan.

Age Division	Maximum Tournaments (including home)	Maximum Overnight Tournaments
U13, U15, U18	6	2
U11	5	2
U9	4	1
U7	2	0

- 4.2. Any additional tournament participation beyond the limits specified in this policy must be approved by the MJMHA Board of Directors.
- 4.3. Teams must be available for all scheduled playoff games. No playoff games will be rescheduled or traded to accommodate a tournament.
- 4.4. U11, U13, U15, and U18 teams are not permitted to book tournaments after March 1st.

5. TOURNAMENT FEES (TIER TEAMS ONLY)

- 5.1. To secure spots in competitive tournaments that fill up before team selection is complete, MJMHA may, upon request from the Tier Director, provide funding to cover up to two (2) tournament entry fees for each AA team, and one (1) for each A team.
- 5.2. Once the teams are finalized, the full amount of these tournament fees must be reimbursed to the MJMHA no later than November 1st of the current season.

6. POLICY REVIEW

This policy shall be reviewed annually or as needed to align with organizational priorities and the regulations of Hockey Saskatchewan. Any amendments must be approved by the MJMHA Board of Directors.
