

Original 6+ Hockey Club, LLC Consent and Waiver (Player)

I, (print or type name): _____ (“**Participant**”) have agreed to participate in an adult recreational hockey league (“**League**”) administered by Original 6+ Hockey Club, LLC (“**Organizer**”). I am providing this signed Consent and Waiver to acknowledge that hockey is a dangerous recreational activity and to expressly release the Organization from liability related to the League.

I recognize and accept that the League involves physical activity including, but not limited to, on ice competition involving muscles, bones, lungs, endurance and cardiovascular activity, including associated risks of bodily injury, mental injury, partial or permanent disability or death from collisions, concussions, broken bones, pulled muscles, abrasions, cuts, bruises, loss of blood, heart attack, COVID-19 and other risks, known and unknown, which risks associated with the physical condition of the facilities where the League activities takes place, including, but not limited to, the ice surfaces, boards, benches, doors to the ice, goal posts, nets, sticks, pucks, locker rooms, showers, walking surfaces, common areas, restrooms, parking lots, and the conduct of other players, team managers, spectators, referees, rink employees; and injuries if any, may require emergency medical care, hospitalization and in some instances may result in death. I also acknowledge and affirm that I am in good physical condition, fully capable of participation and do not suffer from any known disability or condition which would prevent or limit my participation in the League, and to the extent I am aware of any condition that could increase my risk of

harm or injury, I have been advised by a physician that my participation in the League does not present an unacceptable risk of harm or injury. I further acknowledge that my enrollment and participation in the League is purely voluntary and not mandated by the Organizer. I fully understand that I may injure myself as a result of my voluntary enrollment and participation in the League, including hospitalization and death.

IN CONSIDERATION OF MY PARTICIPATION IN THE LEAGUE, AND FOR OTHER GOOD AND VALUABLE CONSIDERATION ACKNOWLEDGED BY ME, THE PARTICIPANT, ON BEHALF OF HIM OR HER SELF, THEIR HEIRS AND ASSIGNS HEREBY RELEASES THE ORGANIZER AND ITS AGENTS, OWNERS, MANAGERS, REFEREES, EMPLOYEES, VENDORS, PROFESSIONAL SERVICE PROVIDERS AND ATTORNEYS, FROM ANY AND ALL CLAIMS, DEMANDS, DAMAGES, COSTS, ATTORNEY FEES, LEGAL ACTIONS, LEGAL CLAIMS, CAUSES OF ACTION AND OTHER CLAIMS RELATED, IN WHOLE OR IN PART, TO MY VOLUNTARY PARTICIPATION AND ENROLLMENT IN THE LEAGUE BY CONVE.

I HEREBY CONSENT TO PARTICIPATION IN THE LEAGUE AND AFFIRM THAT I HAVE READ, FULLY UNDERSTAND AND HEREBY RELEASE AND WAIVE LEGAL RIGHTS RELATED TO MY PARTICIPATION IN THE LEAGUE.
