

# CAMP GUNGHO – WAIVER NOTICE (INFORMATION ONLY)

**Issued by:** Get GungHo Pte Ltd (Singapore)

**Purpose:** This document is a waiver notice and participant risk disclosure.

## IMPORTANT NOTICE

Camp GungHo includes participation in adventure, water-based and high-activity experiences. These activities involve inherent risks which may result in injury, illness, property damage, emotional distress, or in extreme cases, serious injury or death. Parents/guardians should read this notice carefully before registering their child.

**This waiver notice does not replace the formal third-party operator waivers.** Certain activities are operated by third-party providers who may require additional participation agreements and waivers to be signed.

## ACTIVITIES COVERED BY THIS NOTICE

HydroDash (floating inflatable obstacle course – Sentosa) HyperDrive (electric go-karting – Sentosa) Skyline Luge Singapore (Luge rides and Skyride – Sentosa) Mega Adventure Park activities: Mega Bounce, Mega Climb, Mega Jump, Mega Zip

## GENERAL ACKNOWLEDGEMENT OF RISK

Participation in Camp GungHo activities may involve (without limitation): slipping, falling, collisions, drowning risk, height-related risk, equipment failure, unpredictable participant behaviour, environmental hazards, weather-related hazards, and risks arising from travel or transport to and from venues.

Parents/guardians are responsible for ensuring that their child is medically and physically fit to participate, and that any medical conditions, allergies or special needs are disclosed to Get GungHo Pte Ltd prior to the camp.

## SPECIFIC ACTIVITY RISK DISCLOSURES

### 1) HydroDash

HydroDash is a floating inflatable obstacle course over open water. Risks may include falls into water, collisions with obstacles or other participants, drowning risk, muscle strain, cuts, bruises, impact injuries, weather-related hazards, and exhaustion. Participants are required to follow safety instructions, wear flotation devices where required, and comply with operator rules.

### 2) HyperDrive (Go-Karting)

HyperDrive involves electric go-kart driving at speed. Risks may include collisions, rapid acceleration or braking injuries, whiplash, bruising, fractures, impact injuries, and equipment malfunction. Participants must attend safety briefings and follow track rules at all times.

### 3) Skyline Luge Singapore (Luge & Skyride)

Skyline Luge involves riding a gravity-powered cart downhill and may include use of the Skyride chairlift. Risks may include falls, collisions, loss of control, braking injuries, impact with barriers or other riders, injury while loading/unloading, and weather-related hazards.

#### **4) Mega Adventure Park (Mega Bounce, Mega Climb, Mega Jump, Mega Zip)**

Mega Adventure Park activities involve height-based and aerial elements. Risks may include falling, harness discomfort or injury, equipment failure, impact injuries, rope burns, bruises, fractures, and serious injury. Participants must comply with weight/height restrictions, wear safety equipment properly, and follow staff instructions at all times.

### **THIRD-PARTY OPERATOR WAIVERS**

Some or all venues may require participants (or parents/guardians of minors) to sign their own separate waivers, rider agreements, declarations, or indemnity forms. These may include terms and conditions imposed by the third-party operator. Participation may be denied if such waivers are not accepted.

### **PARENT/GUARDIAN AUTHORISATION (CHECKBOX CONSENT)**

By registering for Camp GungHo, the parent/legal guardian may be asked to provide digital checkbox authorisation confirming consent for participation and authorising Get GungHo Pte Ltd to sign certain third-party venue waivers on the parent's behalf where required.

### **MEDICAL & EMERGENCY CARE**

In the event of injury or illness, Get GungHo Pte Ltd may arrange first aid and emergency medical treatment, including ambulance transfer, where necessary. Parents/guardians remain responsible for all medical expenses incurred for their child.

### **PHOTOGRAPHY / VIDEO CONSENT**

Camp activities may be photographed or recorded for safeguarding, operational, and promotional purposes. Parents/guardians may be asked to provide consent for the use of images or video featuring participants.

### **LEGAL NOTICE (SINGAPORE)**

This waiver notice is intended to provide clear disclosure of risks. Nothing in this notice is intended to exclude liability where such exclusion is not permitted under the laws of the Republic of Singapore, including liability for death or personal injury caused by negligence.
